## **MESSAGE**




It is a matter of great joy to come across the fact that, the Odisha State Commission for women is bringing out its Annual Report for the year 2020-21.

## Foreword

Odisha State Commission for Women has passed through a memorable period during 2020-2021. Covid-19 pandemic has engulfed the entire world and its menace still prevails in view of the resurgence of 2nd spell of the pandemic. In this critical time, the Commission has tried its level best to reach out to the women suffering from various angles. Ultimate aim of the Commission has been creating a ray of hope and smile in the face of the woman affected due to a problem, may it be domestic violence or workplace sexual harassment or dowry torture or cyber crime.

This Covid-19 year has changed the modus operandi of the State Commission for immediately taking action on the complaints filed by the suffering women. Commission has published a WhatsApp No.8763543013 through which distressed women have filed their complaints. Besides, through tele counselling and virtual hearing Chairperson and Members have been able to reach to the women found in problem.

Commission has observed its 28th Foundation Day on 14th January 2021 and as a token of recognising the outstanding work done by the Covid-19 women warriors has felicitated 20 such Covid-19 warriors. This felicitation programme was not confined to the State head qrs. But, it was also extended to District/Block level. Covid-19 women warriors of the district are being felicitated in a joint programme organised by the State Commission and District Administration.

As usual Commission has arranged legal awareness programmes and organized Camp Courts at the district/block level. Ultimate purpose to conduct such programmes is to sensitize and educate the women community to assert their legitimate rights for living a meaningful life with dignity and self esteem. Jail & Swadhar Greh visits has another important area to mix up with the inmates, realise their problems and to find out ways to solve their real problems.

There is no denying the fact that practices of sorcery & witch craft in certain districts of the State has caused serious social disharmony and resultant loss of lives. The problem is deep rooted in all the tribal dominated districts of the State and despite the implementation of the Orissa Witch Hunting Act-2014, the impact of the social evil has not been reduced to a considerable extent. There is much scope to be done on this count. Realizing this, State Commission has begun conducting a research study on witch hunting for bringing a full fledged enabling rules styled as 'Orissa Witch Hunting Rules' for appreciably curbing the evil practices and educate the tribals of its evils and serious consequences.

## About the Commission

Government of Odisha set up the Odisha Commission for Women to protect, preserve and safeguard the rights and interests of women and deal with atrocities and offences against women in the State. Basic objective of the Commission has been for ensuring a women friendly society where the dignity & security of women in every sphere of life is well protected and women can enjoy their life without fear and despair.

State Commission for Women aims at rendering unbiased support to the Government in formulating policies and implementing laws to improve the socio-economic status of each and every woman and girl to aware of her rights for living a life with dignity, safety and security as a member of the society.

## Major Functions of the Commission

- ❖ Speedy justice delivery without any financial burden on the affected parties,
- ❖ Resolution of complaints,
- ❖ Imparting training to all the stakeholders involved in improving the status of women,
- ❖ Doing advocacy for policy level changes and their amendments,
- ❖ Organising camp courts to reach out to women living in remote areas,
- ❖ Training & Orientation of organisations and institutions providing services to women,
- ❖ Offering internship programmes to law students.
- ❖ Undertaking research study on need based for protection of interest of women and to recommend to the Government for consideration.

## Investigation of cases as a civil court U/s 10 (3) of the State Commission for Women Act, 1993

State Commission enjoys the power of a Civil Court trying a .... and in particular, in respect of the following matters namely : -

- ❖ Summoning and enforcing the attendance of any person from any part of India and examining him on oath;
- ❖ Requiring the discovery and production of any document;
- ❖ Receiving evidence on affidavits;
- ❖ Requisitioning any public record or copy thereof from any court or office;
- ❖ Issuing commissions for the examination of witness and documents and any other matter which may be prescribed.



## Composition

As per "The Orissa State Commission for Women Act, 1993", the Commission comprises of :

1. a Chairperson, who is an eminent social worker or a professional committed to the cause of women to be nominated by the State Government;

2. Six Members to be nominated by the State Government from amongst persons of ability, integrity and standing of whom:

(a) One shall be an official,

(b) One shall be an eminent advocate,

(c) two shall be social workers of repute , and

(d) two shall be experts in education and health,

Provided that at least one Member shall be from amongst persons belonging to the Scheduled Castes and the Scheduled Tribes respectively.

## Different Cells and their Activities

### Legal Cell

The Legal Cell consists of 02 (two) Legal Assistants and 10 Dealing Assistants. After receipt of petitions from the Diary Section, the Dealing Assistants prepare a synopsis of the case and put up the file with concerned letters received from the petitioner/opposite party/S.P/LSA/Collector/OIC and other officers to the Legal Assistants for their suggestions. The Legal Assistants examine the file with reference to the petition/complaint received, give suitable suggestions and endorse the file to Chairperson/Convenor Secretary for their perusal and orders. Then the Dealing Assistants carry out the orders made by the Chairperson/ Convenor Secretary. Legal Cell also issues summons to persons not attending to the Commission as per requirement.

Besides, dealing with petitions/complaints of the aggrieved parties, this cell organises Camp Courts (Lok Adalats and Janasunanis) at the district/ block level, takes care of Assembly questions and conducts Board Meetings as and when required.



## Research Cell

The Research Cell is manned by a Research Assistant who registers all the files received by the Commission from the petitioners district wise on a daily basis. The Cell compiles month wise and district wise data on registration of various types of case like dowry death, dowry torture, domestic violence, rape, sexual harassment, workplace harassment and other cases. At the year end, the cell compiles the data year wise.

Besides the above, the cell provides data for press and assembly questions, deals with NCW & SCW files and RTI matters of the State Women Commission.

## Investigation Cell

The Investigation Cell deals with such disputes which are not resolved through counselling sessions. These require further investigation by the Police which are expedited and monitored by the investigation cell. The duly constituted inquiry committee conducts spot enquires for dealing with serious crimes. While conducting enquiry, witnesses are being examined, evidence on the incident collected and thereafter the committee submits its reports with recommendations. Such investigation provides immediate relief and justice to the victims of violence and atrocity.

During the year 2020-21, the cell has investigated and submitted reports on 03 (three) cases.

## Accounts Cell

This cell comprises of an Accountant-cum-Storekeeper and a typist. The cell deals with the office establishment and stock & store charges. Original vouchers/records of the bills are safely maintained by the cell for audit compliances. It also calculates and draw the monthly honorarium and T.A. & D.A etc. of Chairperson and other Members and draw the salary & wages of Staff. The cell maintains the Cash Book for the day to day expenditure of the Commission.

## Counselling Cell

The Counselling cell comprises of 03 (three) Counsellors which constitutes an important segment of the Commission. It conducts counselling on different allegations as submitted by women in distress. Many petitioners approach the Commission for counselling / advice even before submitting their complaints. In fact, many of the complaints are resolved through counselling processes. Post-marital counselling and pre-marital counselling help women in distress immensely in offering appropriate solutions to their problems / mis-understanding.



During 2020-21, 2461 nos. of counselling sessions have been held, out of which 107 cases have been settled.

### Library, Publications and IEC Material

Publication wing of the Commission has been constantly trying to bring out something new for strengthening women's cause and adding to their well being. During 2020-21, Commission published 02 books i.e. Hasa Phutila-Paribar Tisthila(containing the success stories of the commission) and FAQ on the problems faced by a women and their solutions. Besides, Annual Report for the year 2019-20 was also published.

Programme was highly successful and ended with active participation of all participants.

### **Legal Awareness Programme at Mahanga Block**

One day legal awareness programme was organised by the Odisha State Commission for Women in active cooperation of Mahanga Block Self Help Mahasangha of Cuttack district on 18th December 2020 at about 11 AM. in which one hundred women president and secretary of different SHGs attended.

Ms. Gayatri Parida (In charge CDPO) and Mr. Vivekananda Samantaray were coordinating the programme.

There was vivid discussion on the rights of women and how the women will address the violence (from home to workplace) through different legal steps. The topic was on Protection of Women from Domestic Violence Act 2005, Prevention of Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act 2013, PCPNDT (Pre-Conception and Pre Natal Diagnostic Technique Act, Immoral Traffic (Prevention) Act, Protection of Children from Sexual Offence Act 2012, Child Marriage Prohibition Act, Cyber Crime and Role of Police. The Chairperson emphasised on the toll free number of different helpline.

The entire session was in a participatory method. The participants also asked questions on violence which they are facing in their home due to consumption of liquor by the male members of the family. Because of this addiction, the women are suffering from physical, mental and economical torture. The Chairperson and other speakers cleared their doubts in a very convincing and friendly manner.

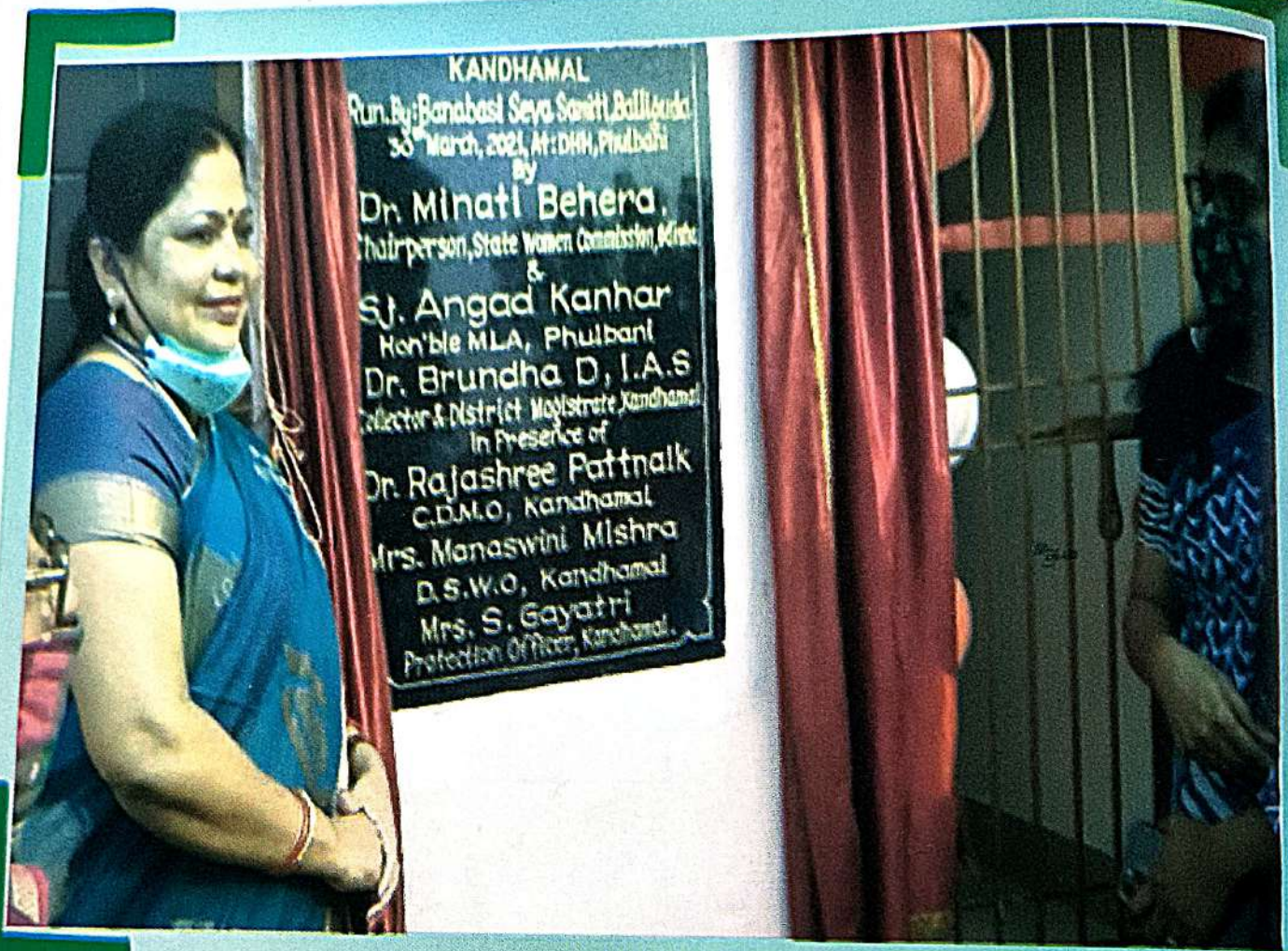

## **PARTICIPATION OF STATE COMMISSION FOR WOMEN IN THE ONLINE DISCUSSION (WEBINARS)**

Odisha State Commission for Women has organised / participated in the Webinars during 2020-21 as summed up below:

**10/07/20 - 'Trafficking in Women : Emerging Challenges, Barriers and Rehabilitation Provisions'.**

The National Commission for Women organized an online discussion on the topic 'Trafficking in Women : Emerging Challenges, Barriers and Rehabilitation Provisions' on 10/07/20. Chairperson along with Members participated in the virtual discussion. Prime motto behind conducting such discussion was to highlight the challenges & threat of trafficking in women and the necessity of enacting stringent legislation to curb its menace.



**26/08/20 - 'Strengthening Online Complaints & Investigation System, Increase in domestic, Sexual and gender based violence during Covid-19 Pandemic and steps taken by SWCs to address these issues'.**

The National Commission for Women had conducted an online interactive meeting with the State Commissions for Women on how to strengthen on line complaints & investigation system. Further, the steps taken by the State Commission to deal with the issues of increase in domestic, sexual and gender based violence during Covid-19 was another important item of discussion of the above meeting. Cyber Crime Cases and how to address it also figured in the discussion. Distinguished Panelists offered their valuable inputs on the selected subject of discussion.

**31/08/20- One day Law Review Consultation on "Cyber Crime against Women -Do Indecent Representation of Women's Act, IT Act and other prevailing laws suffice?"**

NCW organized one day interactive meeting on the above subject. The objective of the consultation was to review and analyse the development of regulatory instruments, statutes, recommendations, guidelines etc. pertaining to Cyber Security frame work for women. An endeavour was made to formulate consolidated recommendations for viable amendments in the existing law in the interests of women.

**20/10/20 - 'National Education Policy 2020- Gender & Sexuality'.**

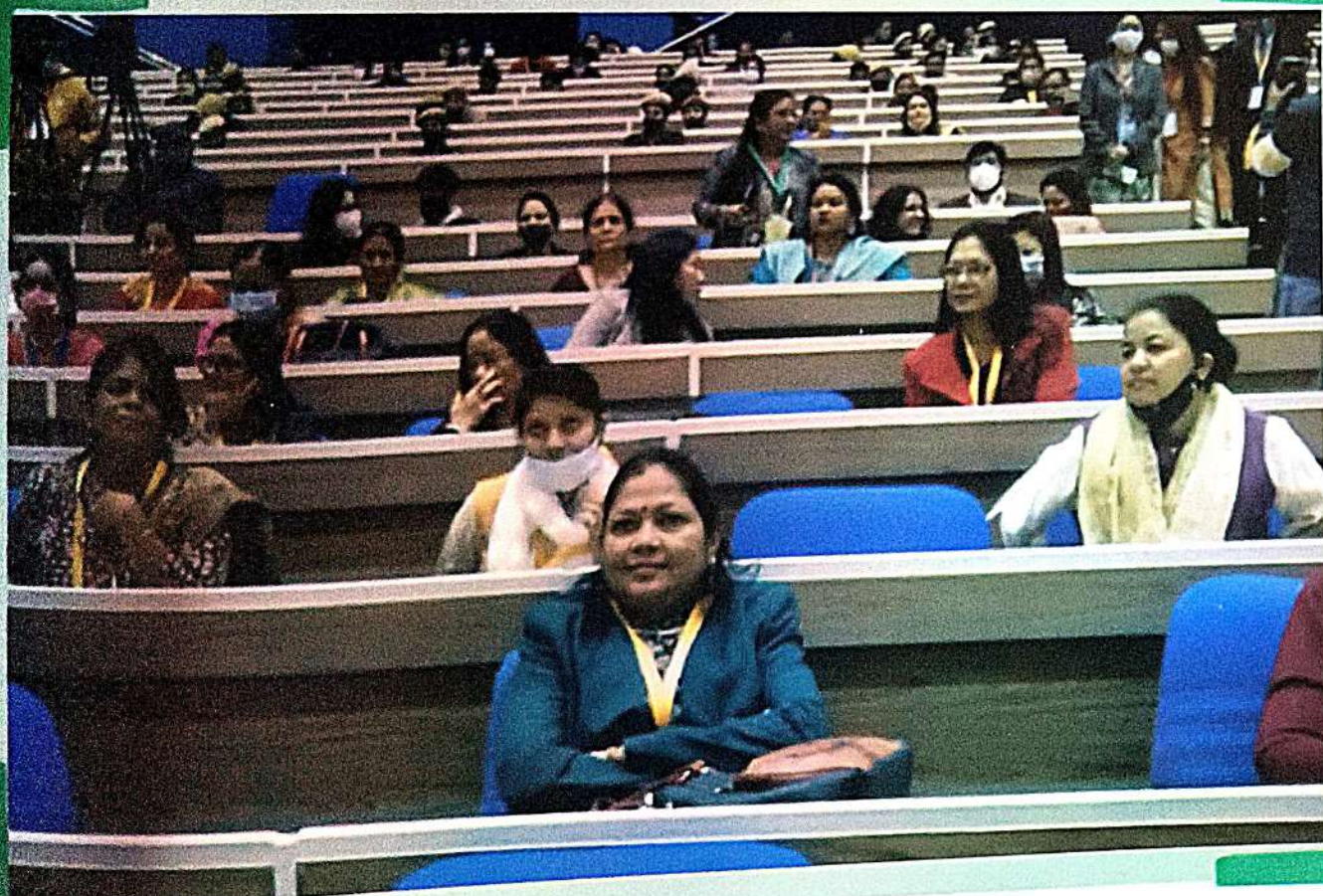

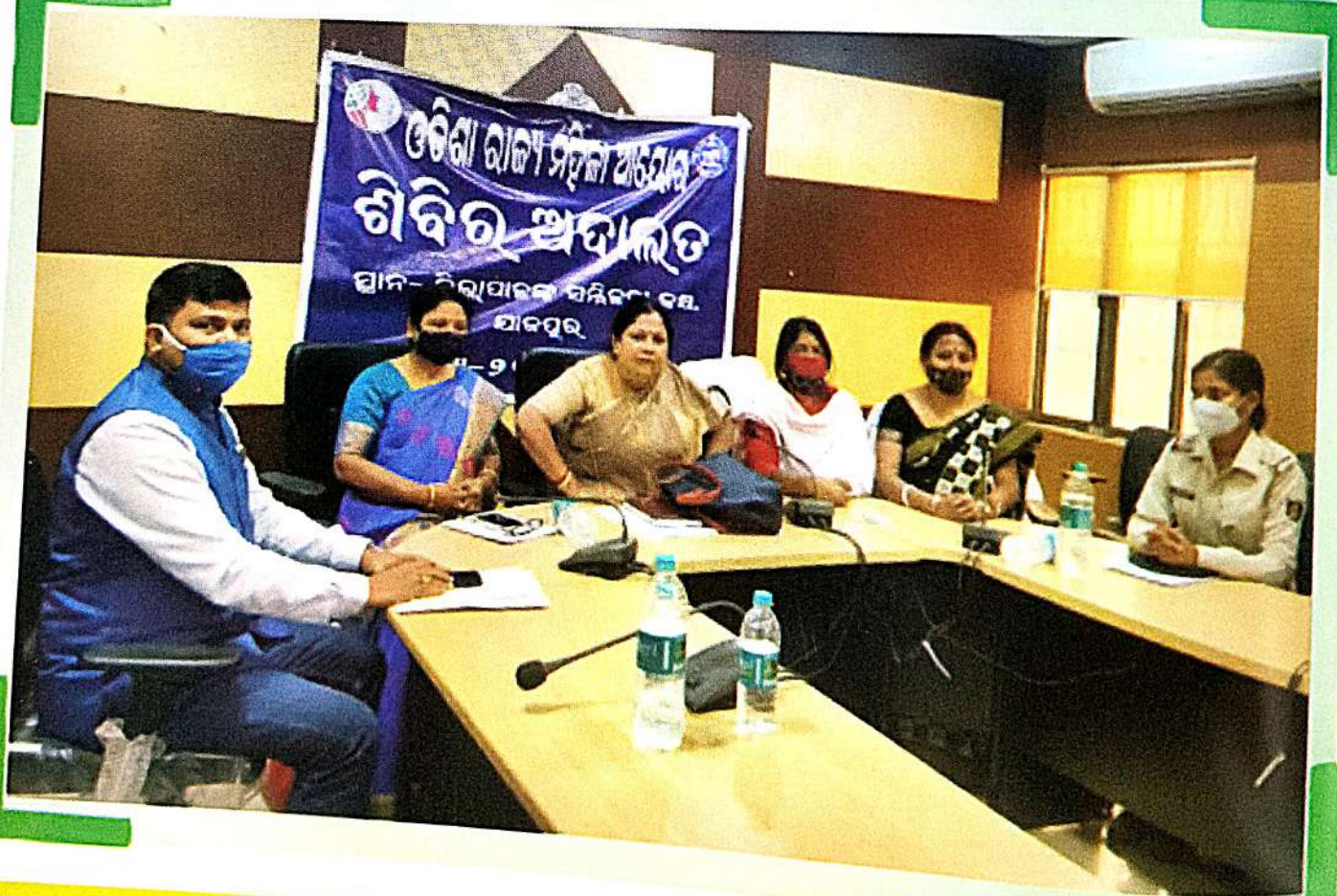
